## Mum in hot water over viral video of toddler 'taking meth'

sungal Petanii To her, taking a video of her 3-year-old son inhaling "syabu" with a meth pipe was nothing but a joke to get her husband riled up but the act has backfired on the woman.

The 27-year-old woman from Gurun is now looking at the possibility of losing custody of the child.

The woman had collaborated with her boyfriend to record a 16-second clip which showed her son sitting at the back seat of a car, holding the meth pipe.

Athrash Wahid said the woman
denied that her son had been
forced to take meth as the pipe
the boy was holding in the video

"The woman claimed that she only took the video to lurrt the feelings of her husband.

"Both the woman and her son were referred to Sultan Abdul Halim Hospital (SAHH) to have their blood samples taken for analysis. Initial results showed that the child was free of any

traces of drugs," he said in a statement yesterday.

Mior said the woman, who had a record for a drug-related offence and possession of a dangerous weapon, was not remanded as she was eight months' pregnant.

He added that police were look-ing for the woman's boyfriend, who bolted as soon as the video went viral.

Police have classified the case under Section 3(1)(a) of the Child Act 2001 and have informed the Kuala Muda Welfare Department

on the incident.

Meanwhile, the Welfare Department was not amused with the woman's explanation.

Its state director, Md Noor Chik, said the department had initiated a procedure to place the boy under the department's custody under Section 3 of the Child Act, until police investigations on the case was completed.

Md Noor said at present, the boy was still warded at SAHH for further medical check-ups.

He said checks revealed that the woman had been separated from her husband since last year
